Company Contract, Rules & Regulations

- 1. Students in "The Nutcracker" are eligible to audition for "Jungle Book", performances March 1 & 2, 2019. Required casting audition on October 20, 2018 at the Northwest Studio for Ballet. Please check the box if your child will participate.
[] Yes, my child will also be available for the "Jungle Book" production.
2. Check the rehearsal schedule carefully and frequently. All conflict dates must be submitted in writing to Yukari Thiesen by 8/1/2018. All dancers must attend August 11 through August 17 rehearsals with Ms. Marina Fliagina and November 19 through November 23 at the Saroyan Theatre. These dates CANNOT be included in your conflict dates list. We will not accept any other dates of absence besides the dates you submit.
3. If a dancer misses a rehearsal that is not on the list of conflict dates, it will be count as an UNEXCUSED Absence. Only one unexcused absence is allowed. If there is a second unexcused absence, the dancer will be removed from the production.
4. Dancers are required to arrive 15 minutes prior to all rehearsals and promotions and be ready to participate.
5. Failure to follow company rules including 1) not meeting standards for ballet technique 2) not attending rehearsals without prior arrangements and/or notice, 3) causing problems during the rehearsal and 4) not participating in the fundraisers, will cause the dancer to be removed from the cast. If you child is removed, there will be no refunds for ticket deposits or the money collected from Raffle Ticket sales.
6. Dancers will arrive and sign in 90 minutes before every dress rehearsal and performance unless directed otherwise by supervisors. Dancers must sign in for each performance.
7. While in the theater, dancers are required to stay in their assigned dressing rooms.
8. All dancers except those who are dancing the role of Waltz of the Flowers will have their makeup applied by the makeup department.
9. Dancers may not eat or drink (except for water) when in costume.
10. Food and drinks (except for water in an appropriate container) are not allowed in the dressing rooms.
11. Dancers may not use body make-up or glitter.
12. Each dancer is required to sell a total of 10 Nutcracker tickets and 2 Jungle Book tickets. A deposit of \$366.00 for 12 tickets from the least expensive section is due on 7/21/2018. Payment for ticket upgrades is due when ticket orders are placed. Ticket order forms will be released to each dancer on September 1, 2018. The TICKET ORDER DEADLINE for the NUTCRACKER is NOVEMBER 1, 2018. Tickets will be released after receiving your written ticket order which should include any ticket upgrades, specific dates and time, and number of adults and children. FBT Member Discounted Ticket Prices: Adult \$70.50, \$60.50, \$50.50, \$30.50 • Child (12 & under) \$30.50 throughout the theater. Divided payments are an option. Post-date three checks for \$122, \$122 and \$122. Your deposit must be paid in full by September 21, 2018.
13. All Ticket sales are final. There are NO REFUNDS.
14. Each dancer is required to sell 40 tickets, at \$5 each. Prizes are \$1,500, \$1,000 and \$500 in cash. Raffle tickets are available at the studio now or will be released to you on August 11 & 19. Payment for the raffle tickets (\$200) is due on Sunday 9/23/2018.
15. All parents are required to take on at least one volunteer position for the production. To opt out you may donate \$100 to VPAC. Make your check payable to VPAC and submit payment by 9/7/2018.

Violation of this contract may result in removal from the performances.
